## Chamber Hosts Fly-In of Delegation of Parish and Business Leaders to Washington, D.C. to Address National Flood Insurance Program

**METAIRIE, LA** – September 11, 2013 – At the peak of hurricane season in the Gulf South, the <u>Jefferson Chamber of Commerce</u> will host 29 business leaders and local elected officials for a trip to the nation's capital from September 11-13 to discuss and promote the Chamber's federal legislative agenda, including important issues concerning the National Flood Insurance Program and its impact on Jefferson Parish and surrounding areas.

One year following the devastation of Hurricane Isaac, the group will meet with members of the Louisiana congressional delegation and key departmental staff and representatives of the U.S. Chamber of Commerce to voice concerns over the Biggert–Waters Flood Insurance Reform Act of 2012 and FEMA preliminary flood maps.

"Generations of Louisiana home and business owners have made lifelong plans and investments based on the existence of affordable flood insurance," said Todd Murphy, Jefferson Chamber President. "Increased insurance rates and changes to the flood insurance maps would be devastating to residents and the business community of Jefferson and our neighboring parishes. We are making it a priority to voice our concerns on Capitol Hill and look for viable solutions."

According to a <u>poll</u> conducted by the Congressional Management Foundation, 46 percent of surveyed congressional staffers said that in-person visits are very influential in helping them form opinions.
